We are pleased to confirm that your group’s insurance cover is provided under TOURS FOR CHURCHES’ Travel Insurance Policy. Please take the time to read the insurance policy enclosed with this letter to ensure this meets your group’s needs.

There are some important points we need to bring to your attention, which require **action on your part**.

Please ensure that:-

- Each parent, guardian or other party member has been referred to TOURS FOR CHURCHES’ website <http://www.toursforchurches.co.uk> to read and understand the Key Facts and Insurance Policy.
- You understand that Tours for Churches ‘free’ travel insurance cover **DOES NOT** apply to travellers aged **75 years or over** at the time of departure, but it is available for an additional premium. **Please contact Tours for Churches for information and to arrange travel insurance if applicable to any of your group.**
- **Pre-existing Health Conditions:** You understand the policy’s pre-existing health condition declaration requirements and you are aware of your group’s responsibilities to notify Fogg, applicable as follows :

\* For the adults travelling on the trip, this also includes any close business associate.

If you need to make a health declaration (as per the above table) Fogg will advise you of any special terms, give you a helpline reference number, and confirm in writing.

- **Cancellation:** You understand that claims are paid at the time the event or the new diagnosis is made which makes it necessary for the person to cancel. You need therefore to advise **TOURS FOR CHURCHES** as soon as possible if any member of your group needs to cancel.
- **Travelling in the EU:** You should advise all party members to obtain and to carry a valid European Health Insurance Card (EHIC).
